

**AUDITION CALL FOR PROFESSIONAL DANCERS****GUY NADER | MARIA CAMPOS – MERCAT DE LES FLORS / CÈL·LULA (CELL) # 3**

GN|MC Guy Nader | Maria Campos, in collaboration with Mercat de les Flors, is seeking for professional dancers with a high technical level on partnering and floor work for a new creation for the year 2020-21.

This new creation project is based on the vocabulary that GN|MC has developed in their latest creations, using specific physical tasks that involve pattern of repetition and group collaboration characterized by high precision and rigor in relation to the notion of time and space.

Dancers will be preselected during a first audition in March and will be invited to participate later on a research LAB in June 2020 for final decision of the team for the project.

This is a proposal of the CÈL·LULA#(CELL) program of Mercat de les Flors and is co-produced by Festival Grec.

**PROJECT CALENDAR**

The **AUDITION** will be held from **2nd to 6th March 2020** in Barcelona to select dancers who will take part in the first process of the creation.

Preselected dancers from audition will be invited to a **RESEARCH LAB** from **15th to 20th June 2020** in which the final team of performers for the creation will be decided.

**CREATION** period will happen in two phases, the first one during 2020 and the second phase during 2021. The following availability is required for these phases:

- Phase 1) from **August to November 2020**: creation period and rehearsals.
- Phase 2) from **March to July 2021**: creation period, premiere at Grec Festival on July 2021 and Autumn performances at Mercat de les Flors included.

(Exact dates for rehearsals, premiere and performances for 2020 and 2021 to be specified)

### **CANDIDATES REQUIREMENTS**

- Availability for the whole audition dates.
- Availability for the whole rehearsal period and performances.
- Training and professional experience.
- **IMPORTANT: High technical level of floor work and partnering.**

- Announcement for the audition with or without admission upon submitted material (CVs and videos) will be on 17th February 2020.
- Audition from 2nd to 6th March will take place at GRANER (Jane Addams Street 16-18, Barcelona, Spain)

- The research LAB is by invitation only.
- There will be a pre-selection based on your video and CV.

- The final contracts and engagement with dancers will directly hired by GN|MC Guy Nader | Maria Campos.
